COURT OPINION

The Second District in Duncan vs. Flynn 342 So2nd 123, had an interesting confrontation with the question of when a newborn baby had a separate and independent existence so as to give rise to an action for wrongful death.

Mrs. Duncan was taken into the delivery room where Dr. Flynn attempted delivery. The baby's head emerged but the shoulders were too wide to allow further passage. After several unsuccessful attempts to complete the birth, the Doctor noted that the heart beat had stopped in the baby and concluded that the baby could not be alive and directed that the baby's head be removed and that the remaining body be taken from Mrs. Duncan by Caesarean Section.

The Third Amended Complaint sought recovery for the baby's wrongful death. The trial court entered a Summary Judgment in favor of the Defendant and the Second District Court affirmed.

The Court in its opinion states that there are no Florida cases to the precise question as to when a live birth occurs. The Court then reviews some of the cases at common law. One case held that a whole child had to be brought into the world and that no live birth had occured until the child had been completely expelled and had obtained a separate independent existence. The Court further cites Bennett vs. State 377 P. 2nd 634, a Wyoming case where the question as to whether the baby was alive was one for the

jury and the turning point came down to whether or not the child had actually breathed. In the instant case, the head of the baby did emerge and the cause of death was listed on the death certificate as "cardiovascular failure due to a consequence of strangulation". The inference is that the baby must have been breathing to strangulate and since there was a death certificate then it must have been alive.

The Court however goes on to define what would be a death for recovery under Florida Wrongful Death Statutes. The definition in the Statutes declares "the death of any person". Wherefore the court reasons that even if this was a live fetus it was not a "person" and that the baby must be born alive and have independent and separate existence. There has to be evidence that the cord is cut and the infant has an independent circulation of

An interesting question arises as to whether or not there was a tort over and above the wrongful death Statute and of course, whether or not there was negligence in the doctor in not diagnosing and not being aware of such a large baby, which was over 14 pounds, and prepared for a Caesarean Section in the first place.

1. The above chart assumes that the custodian of dependent children is employed and not a dependent. A dependent wife should be counted as two dependent children as a guide in determining support.

 Use lower figure take-home pay to determine support. Do not interpolate. (i.e.) Use \$50.00 for all take-home between \$30.00 and \$70.00 per week.

3. A small charge will be added to the above figures to pay expense of clerk in keeping records.

4. Additional payment may be ordered after hearing for extraordinary medical expense, education, etc.

5. Allocation of dependents for tax purposes will be made by the court in the final decree.

The Family Law Section has sixty (60) days to study the schedule and made recommendations to the Bar-Bench Court Reorganization Committee. If the Section makes no recommendations, the court will adopt the schedule and it will become an administrative order.
