#### Report of the Members of The Board of Governors

In accordance with the procedure established in the June issue of the Broward Barrister, the following will be the report of the three members of the Board of Governors from Broward County of the business conducted during the meeting of the Board of Governors of the Florida Bar at Homosassa Springs, Florida, July 6 through July 8, 1978.

(The entire morning on Thursday, July 6, 1978, was spent in executive session during which the Board of Governors considered disciplinary actions and client security fund matters and the administration of necessary private reprimands.)

official legal newspaper for the Seventeenth Judicial Circuit (The president of the Florida Bar, Robert Floyd, announced the appointment of the members of the various standing committees and special committees and his appointments were approved by the Board of Governors.)

(Recommendations were made for appointment on the Board of Bar Examiners for the seats held presently by Alexander L. Hinson of Quincy and Earle M. Johnson of Jacksonville.)

Former Board of Governors member from Broward County, John Neely, was nominated and approved as The Florida Bar representative on the Board of Governors of the Florida Medical Malpractice Joint Underwriting Association. This will, however, be subject to acceptance by Mr. Neely.

President-elect David Shear gave his report which included the announcement that the meeting place for the 1980 Florida Bar convention was designated as the Boca Raton Hotel in Boca Raton, Florida.

After a thorough discussion, including the consideration of several counter-proposals, the report of the Designation Coordinating Committee was accepted and the following changes to the 23 approved areas of practice under the Florida designation plan were adopted:

The Board then considered a resolution proposed by the Judicial Administration, Selection and Tenure Committee requesting the Judicial Qualifications Commission to adopt specific criteria for consideration in determining the removal of a judge or justice for "professional incompetence." It was decided to defer action on this resolution until the September meeting with a direction to President Bob Floyd to meet with the chairman of the Judicial Qualifications Commission to discuss this and to report back to the Board the results of such meeting.

(The Board then voted to authorize the filing of several lawsuits to enjoin several alleged instances of unauthorized practice of law. Most of these would be filed in an effort to obtain judicial determination of the boundaries of conduct permitted by those not members of the Bar without infringing into the field of the practice of law.)

(President Floyd announced a meeting of all section chairmen at the Tampa Airport Host Hotel on Friday, September 22, 1978.)

A general discussion was held concerning various proposals to reduce the costs of the annual Florida Bar Convention for registration fees, luncheon and banquet costs and other expenses incurred by those in attendance. Several helpful suggestions were passed on to the Convention Committee, although it was recognized that this is a continuing problem brought on by the rapidly spiraling inflationary trend. There was also a thorough general discussion of means which could be used to cut down the time expended in the general assembly sessions so that they could be adjourned in a timely fashion.

After a long discussion, most of which concerned the appropriateness of the subject to be considered by the Board of Governors, a resolution was adopted condemning the treatment of Anatoly Shcharansky and other Soviet Jews by the Soviet Union in denying them their right to emigrate as being an infringement upon their basic human rights.

A very comprehensive report was given by Bar counsel, Richard McFarlain and Bill Wiley, regarding the legislation emanating from the Florida Legislature during its last session. They stated that although some legislation to which the majority of the members of the Florida Bar were opposed did become law, they felt that they were able to obtain the best results possible in view of the present make-up of the legislature. They pointed out that prospects for future sessions were grim, and all members of the legal profession should take individual action to assure more favorable representation in both houses of the legislature.

(The establishment of The Florida Bar Group Legal Services Plan was considered and the Board gave general approval of the concept of the plan

A report was given by Woodie A. Liles, chairman of The Florida Bar Committee on Constitutional Revision, concerning the proposed constitutional changes to go on the ballot this year. It was decided to give consideration at the next meeting to a position of The Florida Bar on propositions 1 and 6 of the proposed constitutional changes which are the only proposed revisions with which The Florida Bar is directly concerned.

A discussion was had of a proposal of The Florida Bar Reapportionment Committee to petition the Supreme Court to provide for a new member of the Board of Governors as a representative of all non-resident members of The Florida Bar. It was decided to defer action on the proposal until the September meeting, and the undersigned will welcome any comments the members of the Bar in Broward County may have upon this issue.

(The last item was a general discussion of the new budget for the Florida Bar which went into effect upon the adoption of the dues increase at the last convention. Since approximately 94% of the dues increase will be devoted to improving the structure of disciplinary procedures and the client security fund, it was decided that the staff would be required to report to the Disciplinary Review Committee of the Board of Governors and that they would monitor the expenses incurred for these purposes.)

The next meeting of the board of Governors of The Florida Bar will be September 14th through 16, 1978, in Palm Bach, Florida. We would like to hear from you on any matters which will be then considered as mentioned herein.

#### **ATTORNEYS ALERT**

It has come to the attention of the undersigned member of the Executive Committee that in certain areas in Western Broward there may be problems in closing vacant land transactions by mail. Specifically, a situation has come to my attention where it appears that an individual posing himself to be an attorney and/or agent for a record titleholder or the owner himself. contacted a well-known real estate broker company and requested a listing agreement to be sent by mail to him for his clients. The listing agreement was sent by mail, allegedly signed by the owner, and pursuant to the listing agreement the property was sold. The transaction closed by mail and the checks were disbursed by mail. The checks in this instance were made to the record titleholders and presented for payment and deposited to a local bank. It was subsequently learned that in fact the record titleholders had no knowledge of the transaction and that the person who claimed to be the attorney and/or agent for the record titleholder or the owner, was an imposter and apparently negotiated the checks to his own account. It is suggested that when handling vacant land transactions by mail, that adequate precautions be taken to insure yourselves that you are dealing with the actual owners.

N.A. in Winston-Salem, North Carolina. It is estimated that it would take such a check at least 10 days to clear.

Of particular concern to attorneys is the problem of accepting these out of town checks and then being expected to immediately disperse trust accounts checks on these same funds. If trust account checks are issued on such uncleared funds, it could result in the dispersement of other clients funds and therefore a violation of The Florida Bar Trust Account rules.

It is suggested that clients be notified that such checks are not acceptable in situations where immediate dispersement is required.


