PRESIDENT'S MESSAGE

Our Association's three-year effort to reapportion the Board of Governors on a one lawyer—one vote basis continues. Last November the Board petitioned the

Florida Supreme Court to grant an additional seat to Broward, Dade and Leon Counties, these being the more vocal advocates of apportionment based upon lawyer population. In addition, the Board proposed that the President-Elect of the Young Lawyers Section be given a vote. This proposal would permit 39% of the resident members to elect a majority of the Board. The Board's plan has a range in lawyers represented by one Board member from a low of 85 to a high of 732, 508 being the average number of lawyers represented by one Board member. Broward would have only 84% of its entitlement with each of three Board members representing 607 lawyers.

At the direction of our Executive Commttiee, I opposed the Board's plan by Brief and in Oral Argument before the Supreme Court on January 4, 1978. I submitted a plan for apportioning the Board and for creating a Representative Assembly, as done in Michigan, each based upon one lawyer—one vote. Members may obtain copies of the Pleadings and Briefs from the Association office at reproduction cost. The Court as of this date has not ruled.

Significantly, Dade County joined our Association in opposing the Board's petition. Our two counties contain 40% of the resident membership of The Florida Bar.

The Board's plan was supported by Briefs filed by the Government Bar Association (Tallahassee), the Tallahassee Bar Association and the Young Lawyers Section, joined in by the presidents of the Broward and Dade County YLS as to the two Board seats and votes granted their State President and President-Elect.

In rebuttal argument, the Board Representative stated that the Board of Governors was not, strictly speaking, a "representative body" for lawyers, and therefore, "one-man—one vote" was not mandated.

The Florida Bar in its reply Brief stated that the foregoing assertion "appears to have troubled opposing counsel and perhaps some members of the Court. It is, therefore, important to clarify the intent of such statement. Although each member of the Board of Governors is elected by lawyers in his or her circuit and thereby should bear and does feel a personal responsibility to them (as well as to the members of The Florida Bar as a whole), the Integration Rule of The Florida Bar defines no such duty."

Financial Statement PER CURIAM.

(1, 2) Upon consideration of the briefs and record on appeal we are of the opinion that the order of October 24, 1975 increasing the amount of temporary alimony and providing attorney's fees and costs should be vacated and set aside. The nature and conduct of the proceedings below were such as to prevent a full and complete consideration of all evidence relevant to the issues under consideration. Moreover, the application for temporary alimony, including temporary attorney's fees, was not accompanied by the financial statement required by Rule 1.611, Fla. R. Civ. P., nor supported by competent substantial evidence. Provus v. Provus, 44 So.2d 656 (Fla. 1950); Baruch v. Giblin, 122 Fla. 59, 164 So.831 (1936). Wilson v. Wilson, Fla. App., 351 So.2d 1029.

COURT DECISIONS

The Fourth District Court of Appeals has apparently followed some bad California law in **Brown vs. State** 349 So.2nd 1196. The Appellate Court in affirming the Circuit Court for Orange County held admissable a tape recorded conversation made by an arrestee in the rear seat of a police car without his knowledge.

The Fourth District rationalizing from New York and California decisions, which hold that a prisoner in jail has no reasonable expectations of privacy, to now include persons arrested. It would appear that rather serious Constitutional rights are affected in this decision and that the reasoning and rationale should go beyond the State of California for its pronouncements. The U.S. Supreme Court has spoken on this general matter in numerous cases that could be analyzed to the present factual situation. It would appear without researching the issue that a person arrested without having yet been convicted has available to him the constitutional rights of a citizen far different than the convict and jailed felon. There may be justification for electronic surveillance of jailed prisoners. However, it just does not seem reasonable that a person arrested but not yet convicted or even formally charged can lose this protection against unconstitutional electronic eavesdropping.
