Revision Commission


Speaker: Talbot "Sandy" D'Alemberte, Chairman

Tips From Your Public Relations Committee

DEPOSIT RECEIPT CONTRACT

The Broward County Bar Association and the Fort Lauderdale Area Board of Realtors have jointly approved a new form of Deposit Receipt and Contract for Sale and Purchase, The new contract is a culmination of approximately three years of work by a Joint Committee of the Bar and the Board of Realtors. The purpose of the project was to have available to lawyers and realtors a contract which could be uniformly used within the County and which would contain standard provisions necessary to protect the public. This contract was based on the Deposit Receipt Contract approved by the Bar and the Board of Realtors in 1973. The Committee felt that it was a great improvement on the prior contract in that it more accurately re-

"How Deep Is Deep and How High Is High?"

A rather unique case was decided by the Fourth District Court of Appeal in Jupiter Inlet Corporation vs. Village of Tequesta 349 So2nd 216. Here a condominium corporation brought inverse condemnation action against the Village alleging that the Village had taken water for a public purpose from a shallow aquifer underneath the condominium corporation's land, that they had deprived them of the beneficial use of the shallow aquifer. The Circuit Court granted Summary Judgment in favor of the Village and the Fourth District Court reversed and remanded.

The Appellate Court found "that the shallow aquifer beneath the surface of the land is a form of private property the beneficial use of which the owner of the land can not be divested by the government for public purposes without the process of law and paying full compensation." This is true notwithstanding the fact that the Village did not physically come upon the land but pumped water from the aquifer which drew off of the water beneath the corporation's property. The legal implications at first glance seem to be monumental. Just how far beneath the surface of one's property do rights vest? All of us are sitting on property which may be part of the aquifer furnishing fresh water to the municipali-

ties of the South Florida area. Are rights in the aquifer similar to mineral and other rights imbedded in the real estate? Is there a depth to which ownership would run? That is, here there was a shallow aquifer, whatever shallow is. Is this the same as air rights? In air law a person owns a column of air to the stratosphere. The air above your house is part of the property rights, however, the damages for violating these rights by an airliner going over your property at 5,000 feet does not give, at this time, rise to damages. If the airliner on a landing pattern went over your house at 500 feet, they would be disturbing your right to peaceful enjoyment of that airspace above your property. Further questions in this area still to be resolved are whether or not the destruction of the ozone in your column of air above your property is an asset for which you can be compensated by its destruction and if a matter of proof can be established for damage to your air space, perhaps we will have an entire new area of litigation. Is this same principle to be applied for underground property rights? Are there damages for "shallow aquifer destruction"? Will there, at some point, be damages for deep underground water flow? How does one in law establish damages and proof that this water belongs under this property.

In any event it is an interesting case and one in which the novelty was recognized by the Fourth District Court of Appeal and the question was certified to the Supreme Court:

"Can a municipality be held responsible through inverse condemnation for taking from private ownership for public purposes of underground shallow aquifer water to the extent that the owner is deprived of the beneficial use of the aquifer."
