#### JUDGE BRIDGE TO BEGIN CONFERENCE CALL MOTIONS



#### \* \* \* \* \* PERILS AND PITFALLS OF POOR TRUST ACCOUNTING

There are two prerequisites to prac-



ticing law in Florida: a license and a trust account. Without the former you cannot start your career; failure to have the latter may end it. Actually, merely having a trust account is not enough; in order to avoid disciplinary sanctions a lawyer must scrupulously monitor and maintain it.

Every lawyer practicing in Florida who receives or disburses trust money must certify each year that he is familiar with and in substantial compliance with Integration Rule 11.02 and its accompanying bylaws. Notwithstanding every Florida lawyer's acknowledged compliance with trust accounting procedures, problems with trust accounts are one of the principal reasons for grievance procedures initiated and successfully brought against Florida lawyers. Even a cursory review of published disciplinary proceedings will show that abuses of trust account responsibilities bring the most frequent and the most severe reactions from the Supreme Court.

Practitioners with trust account problems range from those who are ignorant of basic trust accounting procedures, to those who do not properly monitor their trust accounts resulting in temporary imbalances and dishonored checks or even embezzlement by employees, to those fortunately few who simply steal their client's funds.

While most trust account problems can be corrected by improved accounting procedures and more frequent monitoring of the account, others cannot be corrected short of monetary reimbursement to the client either from the attorneys own resources, by claims on his insurance company or by resort to the Client Security Fund.

Monetary reimbursement to a client, however, is often the least of the attorney's problems. The Florida Bar takes a very strong position in prosecuting trust account abuses and the Supreme Court issues equally strong discipline including public reprimand, suspension and disbarment. In any of the disciplinary proceedings brought by the Bar the respondent can be, and usually is, required to pay the cost of the proceed-

The Supreme Court has promulgated strict minimal requirements relating to trust accounts in Integration Rule 11:02 (4). The Florida Bar has adopted Bylaws setting forth minimum require-

ments complementing Integration Rule 11.02. The Supreme Court and The Florida Bar do not promulgate the Rules and Bylaws in an effort to catch the unsuspecting practitioner. In fact, the Bar stands ready at any time to assist any practitioner in assessing his trust account procedures to determine whether they comply with the minimum requirements and to assist in bringing any deficiencies into compliance. The Bar prefers to assist the practitioner in developing good procedures and good habits rather than to prosecute him for infraction of the Rules at a later date.

A brief review of Integration Rule 11.02(4) will show that monies held in trust must be applied only to the purpose so entrusted. It is not subject to a counterclaim or set off for attorneys fees and refusal to account for and deliver entrusted money or property is deemed a conversion. Any practitioner handling any amount of trust money must maintain a trust account, so designated, separate from any other office operating account. The records of his trust account are official records and must be maintained for not less than six years after the last transaction concerning the subject of the entrusted funds. The required records which must be retained included checkbooks, cancelled checks, check stubs, vouchers, ledgers and journals, closing statements, accountings or any other statements of disbursements rendered to the parties with an interest in the entrusted funds.

The required records must be open for audit by the Florida Bar upon request. The mere failure to provide access to the records subject the practitioner to disciplinary action. A practitioner does not have to commit larceny in his trust accounts before he will get in trouble. A dishonored trust account check can lead to an audit of the trust account at the expense of the attorney as well as the possibility of disciplinary proceedings being brought against the

#### YOUNG LAWYERS SECTION NEWS

### The Young Lawyers' President's Column

In its firsts ten years, the Young Lawyers' Section of the Broward County Bar Association has made significant strides in implementing new activities and improving its relationship with the Broward County Bar Association. This new page, the "YLS NEWS" is an illustration of those advances; it is the first time that the Young Lawyers' Section (YLS) has been given continuing and exclusive use of a page or pages in the Barrister. In the months to come, we hope to give all of you, both young and "non-young" lawyers an insight into what the YLS is and what it does for its membership and the local Bar Association.

The YLS is a necessary organization. It brings together lawyers of all ages, regardless of their areas of legal practice, for both social and educational purposes. To the young lawyer, this is most important since the young lawyer (defined for membership purposes as all attorneys who will not attain age 37 during the fiscal year ending May 31) will typically need the assistance or guidance of other attorneys until he or she becomes more familiar with the practice of law, particularly as it exists in Broward County. The educational programs are designed to expedite the learning curve of those attorneys starting their practice for the first time in this locale. Our social programs are intended to introduce the newly admitted attorney to his or her peers as well as to well established attorneys and judges. Although the YLS is also involved with projects intended for the betterment of the local community, the social and educational programs go to the very heart of our existence. This is the Young Lawyers' Section.

In order to encourage membership

in the Broward County YLS, the Executive committee of the Broward County Bar Association has kindly approved several significant changes to the YLS during the forthcoming year. Some of these changes, however, still must be approved by the general membership before they become effective.

Currently, the President of the YLS is a voting member of the Executive Committee of the Broward County Bar Association. Subject to general membership approval, the President-Elect of the YLS will also be given a voting position on the Executive Committee, effective for the fiscal year beginning June 1, 1981. This will hopefully provide a closer relationship between the Broward County Bar Association and the YLS.

Also effective for the next fiscal year, the \$10.00 YLS membership fee, which in the past has been charged in addition to the basic \$50.00 membership fee, has been eliminated in total. Beginning June 1, 1981, there will be no additional fees for membership in the YLS.

In the past, the YLS has received the above \$10.00 dues per YLS member as operating funds for each respective year; however, effective for the fiscal year beginning June 1, 1981, and also subject to general membership approval, the YLS will receive a yet-to-be-designated amount out of the membership dues paid by YLS members to the Broward County Bar Association. Furthermore, all members of the Broward County Bar Association who qualify for YLS membership will automatically become YLS members. The net effect of this arrangement is to provide a broader YLS membership base and increase the amount of operating funds which the YLS will make available for its educational, community and social programs during the next year.

All Broward County Bar Association members, irrespective of YLS membership, always have and will continue to be welcome at any function sponsored by the YLS. It is intended that involvement in YLS activities by non-members will be especially encouraged in the future since a closer working and social relationship is in the best interests of both parties. The new restructuring of dues and membership will serve to accomplish that end.

Lastly and most important, the Executive Committee has voted to reduce the \$50.00 dues to \$25.00 for any attorney joining the Broward County Bar Association and/or the YLS for the last six months of the fiscal year ending May 31, 1981. This special onetime dues proration is intended to encourage new members to join both the Broward County Bar Association and the YLS even before the new dues rates become effective. In the past, there was no proration for any attorney joining the Broward County Bar Association even if it was in the eleventh month of the respective fiscal year.

Because the amount of YLS dues allocation for the next fiscal year will be dependent on how many new YLS members join during the balance of the current fiscal year and for the next fiscal year, we strongly urge each and every eligible attorney, whether or not you qualify for YLS membership, to join the Broward County Bar Association and, if eligible, the YLS for the balance of the current fiscal year.

Only by increased Broward County Bar Association membership, cooperation and involvement can attorneys whether or not they are eligible for YLS membership—improve their legal skills, public image and their own quality of living.

#### YOUNG LAWYERS SECTION BOARD OF GOVERNORS' REPORT

The Board of Governors of the Young Lawyers Section of the Florida Bar met on Friday and Saturday, November 7 and 8, 1980, in Tallahassee at the Florida Bar Center. Highlights if this meeting were as follows:

The Law School Liaison Committee reported on the organization and progress of the scholarship program. Academic credit will be given to law students who are appointed as clerks for Circuit and County Court Judges, and scholarships will be awarded at the Young Lawyers' Convention in April. Nova Law School and the Seventeenth Judicial Circuit are active participants in this program.

The Legal Education Committee reported on the complete revision of the Lawyers Handbook, which is presented to new Bar admittees who attend the Young Lawyers' Section's biannual Bridge-the-Gap Seminars. The first Bridge-the-Gap Seminar was held recently, and it was reported that it was a sell-out success. The Legal Education Committee has also scheduled and begun presenting five, one-day "basic" seminars for new admittees in to the Florida Bar which are spaced throughout the Bar year. During the 1980-81 year, these seminars will increase from five specific areas to seven specific areas. Currently the seminars cover basic commercial litigation, basic trial practice, basic personal injury, and basic discovery.

The Young Lawyers Convention Committee reported on the planning for the Young Lawyers Convention scheduled for April 9 through April 12, 1981, at the Intracontinental Hotel in Miami. The Section will again aim to make the Young Lawyers Convention an affordable, worthwhile, and educational convention so that all young lawyers throughout the state have the opportunity to attend. In the past, for

example, entertainment, dinners, seminars, and meetings have all been provided free of charge. This year's Convention plans include an "Approach the Bench" seminar with outstanding State and Federal Judges participating, and a "Local Section Outreach" meeting for the officers of Sections throughout the state.

The Moot Court Committee reported that the moot court problem is nearing completion or forwarding to the various schools throughout the state. The Local Section Liaison Committee reported on its attempts to begin regular communication with the seven Young Lawyers Sections organized throughout the state and the interest by two additional circuits in forming Young Lawyers Sections. The liaison Committee also reported on the structure and format of the local Section Liaison Meeting which will be held at the Young Lawyers Convention in Miami.

The Young Lawyers Section Newsletter Committee reported on the new and completely changed format for the Newsletter which attempts to create a communication vehicle of interest to all attorneys with various subjects included. The Newsletter is actively seeking articles from Young Lawyers throughout the state and is currently seeking suggestions for a new name.

# JUDICIAL CLERKSHIP PROGRAM ESTABLISHED

Through the combined efforts of the Young Lawyers Section, Nova Law School, and the Broward Circuit Court judges, an innovative new program has

been established to permit third-year students at Nova Law School to earn course credit by working as clerks and research assistants for local judges.

As part of a seminar in judicial administration, each student is required to work for a judge for at least eight hours per week. Almost thirty students enrolled in the program in the first semester, approximately fifteen of whom clerked for circuit judges in Broward County: others worked at Dade County Circuit Court, the Fourth District Court of Appeals, and the Federal District Court.

The first semester of the program ended in late November and was declared to be a resounding success by the participating students and judges who met to critique the program. The second sesmester is currently getting underway.

The student clerkship program is apparently a first in the state, and the Young Lawyers Section of the Florida Bar has expressed an interest in establishing similiar programs in other councounties.

Coordinating the program are Robert A. Dressler, a member of the Executive Committee of the Young Lawyers Section, Professor Laurance M. Hyde, Jr. of Nova Law School, and Circuit Judge Robert C. Abel, Jr.



practitioner. This situation can arise from the careless practice followed by too many attorneys of distributing checks written on trust account monies prior to the funds being deposited into the trust account.

Minimum trust accounting procedures established by The Florida Bar are not merely to protect the client from a dishonest attorney. They are also intended to help the practitioner avoid the pitfalls of sloppy and inaccurate record keeping which can inadvertently lead to trust account violations without any intention of wrongdoing by the attorney. In an effort to educate and acquaint the local practitioners with minimum required trust accounting procedures, the Legal Ethics Committee of The Broward County Bar Association will be participating in the Economics of Law seminar which is being presented by the Committee on Economics of the Broward County Bar Association. #### PRESIDENT'S REPORT

General Master's Report

The Special Courts Committee has recommended that the Reports of the

General Masters be enforced immediately after they have been entered by the General Masters, subject to the review of the exceptions which are filed by a party. The Circuit Court Judges have accepted this recommendation and will implement the recommendation so that upon the filing of the Master's Report, the Judge will enter an Order immediately, requiring the parties to comply with the Report, subject to the Court's subsequent ruling on any exceptions filed by a party.

Certification of Judges

Chief Justice Alan Carl Sundberg, along with Donald Conn, Court Administrator, and Sylvia Alberdi, Staff Director of the Senate Judiciary Committee, visited Broward County on Thursday, January 15th, 1981 for the purpose of considering Chief Judge Tedder's request for new Circuit and County Judges for the 1981-1982 year. Judge Tedder requested three Circuit Judges and three County Judges for the 1981-1982 year and five Circuit Judges and one County Judge for the 1982-1983 year. Judge Tedder and other members of the Circuit and County bench, the Court Administrator, and Bar representatives from the Special Courts Committee, as well as the President and President-Elect of the Broward County Bar Association, were present and participated in the conference, which lasted some three hours, for the purpose of presenting the problems, difficulties and the needs of Broward County for additional Judges. State Senator Kenneth Jenne was also present and participated in the conference.

The Chief Justice was informed of the severe congestion in the Broward County Court system and which results in considerable delay in the hearing of Motions and the trial cases and which has also resulted in the imposition of a Federally mandated jail cap as to the placement of persons in the Broward County Jail. He also was informed as to the various matters being considered by the Special Courts Committee for the purpose of providing for early hearings and Court trials.

In order for the Court to obtain new Judges, the Florida Supreme Court must certify the need for those Judges and the Legislature must enact legislation creating those positions. I believe that a strong showing was made as to the dire need of additional Judges in Broward County to reduce Court congestion and to provide for speedy trials in both civil and criminal cases. We hope that the Supreme Court will certify such need to the Legislature. I am happy to report that there has been very close cooperation between the Bench and the Bar in considering the problems and the needs of Broward County and in presenting the Court's needs to the Florida Supreme Court.
