### Appointment of Elisors

Judge Gene Fischer has announced that the following guidelines will be followed for the appointment of an Elisor:

An attorney desiring the appointment of an Elisor, to serve process, should obtain a waiver on a form as is provided by the Sheriff's Office.

In order to save time and traveling, the Sheriff's Office has arranged that such waivers can be requested in the main Courthouse.

**Joann Burrell** or **Madeline Schagmuller**, in the Circuit Clerk's Office, and **Peggy Cobb**, in the County Clerk's Office, upon request for a waiver, will call the Sheriff's Office and will determine at that time whether a Civil Deputy is or is not available to serve process without unreasonable delay. If service of process cannot be readily undertaken, then the waiver will be issued instantaneously by those Deputy Clerks.

### New Pilot Program to Begin

At the suggestion of Judge Stephen Booher, an experimental program using 4-judge "pods" of Civil Division Judges, all of whom are scheduled for two weeks of jury trials at the same time, will begin in January, 1984. **Administrative Order**

**No. 2.06.02**

**In Re:**

**Uniform Motion Calendar**

In accordance with the authority vested in the Chief Judge by Rule 2.050, Florida Rules of Judicial Administration, it is

ORDERED that each judge of the General Civil Division of the Circuit Court who presently maintains a uniform motion calendar on a regular basis shall continue to do so, under the rules set out below. Those judges presently in the General Civil Division who do not maintain a uniform motion calendar shall establish such a calendar and maintain it regularly thereafter, effective January 3, 1984, under the rules set out below. All judges who hereafter may be assigned to the General Civil Division shall comply with the provisions of this rule immediately upon entry into the division.

A uniform motion calendar is established for each division from 8:45 until 9:30 A.M. four (4) days per week, Monday through Thursday, unless holidays, illness, or similar circumstances prevent. The following provisions apply:

1. Cases are limited to ten (10) minutes; if two parties, each side is allowed

five (5) minutes; if more than two parties, time allocated by Judge.

2. Counsel shall not make appointments with Judge's Assistant but shall notice opposing counsel in accordance with the applicable rules of procedure. A copy of the notice of hearing and a copy of any motion to be heard shall be in the hands of the judge's assistant at least four (4) days in advance of the hearing.

3. Uncontested Proceedings for Adoption, Uncontested Proceedings for Dissolution of Marriage final hearings, and "ex parte" matters will be heard. **All Motions to Dismiss, Domestic Contempt and Temporary Relief Matters will not be heard.**

4. Any party requesting affirmative relief shall furnish the Court with prepared form of order, with sufficient service copies and addressed, stamped envelopes.

5. Motions to Compel Discovery and Motions for Protective Orders shall not be heard unless counsel for the moving party certifies in the motion that counsel has conferred with the opposing party in a good faith effort to resolve by agreement the issues raised and has been unable to do so.

6. At the hearing, the Court will entertain or consider any request for a further hearing if the matter appears too complex to handle on the Uniform Motion Calendar.

7. The moving party shall furnish to the judge at the hearing a copy of the motion to be heard and the notice of hearing. All parties shall also furnish to the judge copies of all documents, pleadings or citations which they desire to consider.
