

President's Message

The success of the Bar Association depends upon the effectiveness of the various bar committees.

The Courts Committee and the Civil Litigation Coordinating Committee were responsible for the Uniform Motion Calendar program and pairing of judges for jury trials that will begin January 1, 1984. Judges Tedder, Lee, Fischer and W. Herbert Moriarty agreed to try the program, and it has been reported that several other judges will participate. Details of the program will appear in the December Barrister. Harry Carratt and Donald H. Norman are Co-Chairmen of the Committees and deserve our gratitude for their dedicated efforts.

The Fee Arbitration Committee under the leadership of Ray Doumar has given many hours to resolve fee disputes. There were 60 requests for information regarding the procedure in the past year. From these requests, twenty-eight (28) applications were filed by either members of the bar or clients, twelve (12) were declinded by the other party. Of the remaining sixteen (16) requests, two (2) settled before arbitration, eleven (11) went to full arbitration hearings wherein Awards were rendered and three (3) were referred to the Courts.

The Legislative Committee has been developed into an excellent Committee by Ellen Gibbs. If any committee or individual should wish to propose any legislation, you should send the information to: Ellen Gibbs, Chairperson, 735 N.E. 3rd Avenue, Fort Lauderale, Florida 33304.

I will give you information from other committees in the future.

George W. Tedder, Jr. Senior Judge 17th Judicial Circuit



Judge George W. Tedder's respect for the bench is something which was instilled in him at an early age. His father, Broward County's second Circuit Court Judge from 1929 to 1955, bequested his love for law to his young son when he allowed him the opportunity to gain firsthand experience by sitting beside him on the bench. Judge Tedder, Jr.'s first encounter with justice, viewed from an overturned waste can, left him with the desire for the study of nothing but the law

Born in Madison, Florida, on July 26, 1922, Judge Tedder's family moved to Fort Lauderdale when he was three years old and he has lived here since. He attended Fort Lauderdale High School, where he served as the first elected president of the student body and upon graduation attended the University of Florida where he received a Bachelor of Arts degree in 1943.

From 1943 to 1946, the judge served in the United States Navy which afforded him the chance to travel through much of the South Pacific and Mediterranean during World War II. After completing his duty with the Navy, Judge Tedder returned to the University of Florida's law school and obtained his degree in 1948. He returned to Fort Lauderdale that year after having decided that "Fort Lauderdale was home, this was where I wanted to be."

After interviewing in Palm Beach and Dade counties, Judge Tedder accepted a position in Broward with the newly established firm of Berryhill and Leaird where he remained in practice for ten years. Elected to the Florida Senate, 30th

district, in 1958, he served from November of that year until December 1960. Displayed on the wall behind his desk is a photograph of him and his fellow Senate members commemorating the honor of his days there. Many of those with whom he served are gone, but those who remain assemble annually to recall the memories of those days. Judge Tedder looks forward to every meeting.

Appointed to the bench in 1960 by Governor Leroy Collins, Tedder has remained there, without exception, for 23 years. On the day of his robing in 1961, Judge Tedder remembers the words of his father, and still holds them true today. "This robe has very little intrinsic value, but if you add the implied meanings its value is tremendous. It is somewhat like the wedding ring which you place on the finger of your bride. It hasn't a great deal of monetary value, but it symbolizes something far greater."

Judge Tedder has served as Presiding Judge for the 17th Judicial Circuit before the courts were combined in 1977, and then as Chief Judge from 1977 to 1981. He has served several times as Associate Judge of the Court of Appeals, 2nd and 4th districts, and as an associate to the Supreme Court.

Raised by parents of strong religious convictions, Judge Tedder's feelings for the church are still firm. He has been a member of the First Methodist Church, downtown, since 1939 and has served as chairman of the Board of Trustees there and Sunday School teacher for several

Judge Tedder and his wife, Sue, have four children: Kathy, George III, Sibley and John. The latter are two residents of Fort Lauderdale. Grandparents once, they are awaiting the birth of their second and third grandchildren—twins.

Still an avid Gator fan, he and Mrs. Tedder enjoy their weekends of the football season in Gainesville where their son George lives and their daughter-in-law Susan studies law at U of F, following in her father-in-law's footsteps. Judge and Mrs. Tedder have thought about leaving Fort Lauderdale to live in Gainesville but something keeps them here.

Remembering the words of his father, Judge Tedder once again is compelled with this message to his fellow officials: "In ancient times, judges' robes were lined with ermine, pure white, the symbol of unspotted integrity. We anticipate in the years, that a judge will not only keep the ermine of the judiciary untarnished and spotless, but that his record will remain untarnished from any unworthy ambition."

Judge George W. Tedder's dedication to the upholding of justice, passed down from his father to him, is an inspiration he has nurtured—to once again pass on.

Grant Awarded

The Young Lawyers Section of the Broward County Bar Association is pleased to announce that it has received a \$1,000 grant from the American Bar Association Young Lawyers Division. The grant will be used for a shared Parental Responsibility project which came through the Family Conciliation Unit of the Broward County Circuit Court system. The project goal is to provide information concerning shared parental responsibility to divorcing parents, professionals and those in the legal community working in the area of divorce. Since the Florida Legislature enacted the Shared Parental Responsibility Act in July of 1982, there have been no agencies that provide information concerning how to deal with joint legal custody, and the Family Conciliation Unit in conjunction with the Young Lawyers Section hope that our program fulfills this need.

We plan to prepare and distribute a brochure which will define the Shared Parental Responsibility law and present guidelines for parents to consider in making shared parental responsibility work for them and their children. In addition, a minimum of three miniseminars will be held for the purpose of educating the general public, mental health professionals and the legal community on shared parental responsibility. During these seminars, a film titled "The Best Interest of the Child" will be shown. The seminars will be scheduled during the fall and winter of 1983-1984.

Fund Gives Grant to All Florida Law Colleges

Annual grants of \$1,000 to support teaching or research in real property law have been awarded to Florida's five law colleges by Attorneys' Title Insurance Fund of Orlando.

The Fund, Florida's bar related title insurer which issues policies through its 5,000 lawyer members, makes the grants each scholastic year. The money is used to support the teaching of real property law or to assist in faculty-student research in the real property field.

The grant program was initiated at the University of Florida in 1960 and since then has been expanded to include the law schools at Stetson University, Nova University, Florida State University and the University of Miami.
