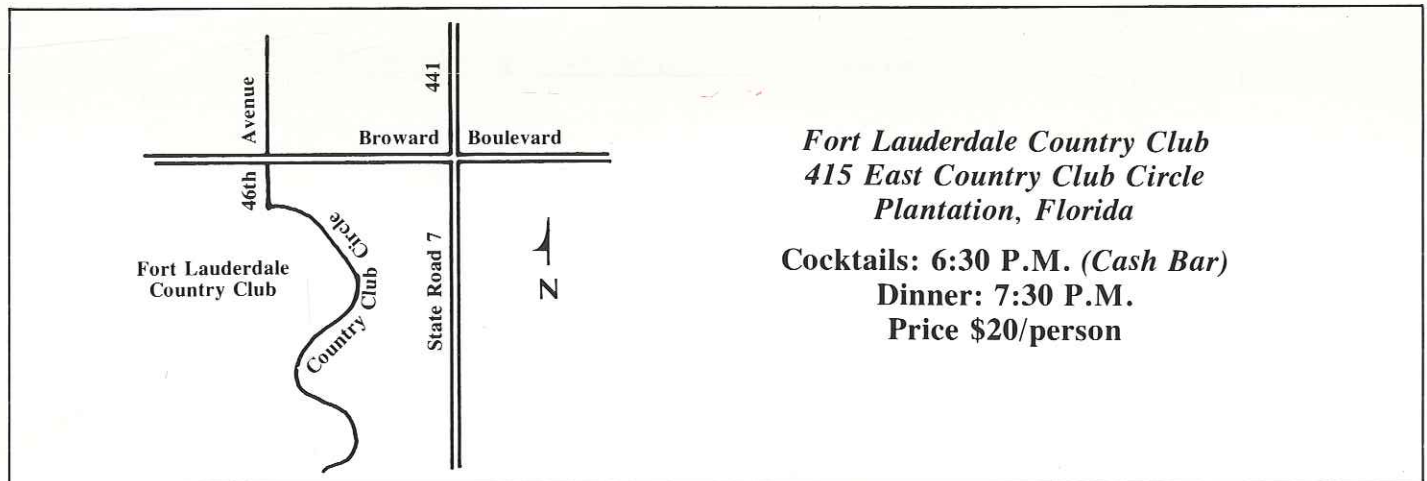

Notice

The Judicial Council of the Eleventh Circuit has formulated its plans to recommend nominee(s) for appointment to the position of bankruptcy judge in each of the judicial districts of the circuit pursuant to U.S.C. §152, which reads:

The President shall appoint, by and with the advice and consent of the Senate, bankruptcy judges for the several judicial districts. In each instance, the President shall give due consideration to the recommended nominee or nominees of the Judicial Council of the Circuit within which an appointment is to be made.

According to current law, all bankruptcy judges are subject to Presidential appointment on or after April 1, 1984. As there are several pending bills before the United States Congress, all persons should be aware that this statute is subject to change and therefore the efforts undertaken by this application and nomination process may be obviated and come to naught.

Any person desiring to be nominated by the Council to the President may call or write for an application questionnaire from the Circuit Executive, U.S. Court of Appeals, Eleventh Circuit, 56 Forsyth Street, N.W., Atlanta, Georgia 30303; telephone 404/221-5724. Those applying must file a completed questionnaire with the Circuit Executive so that it is received not later than February 14, 1984.

Applicants must be (1) members in good standing in the state court in which the attorney practices and (2) admitted to practice in the state in which application is made for at least ten years.

All qualified applicants will be considered without regard to race, gender, or national origin. The salary of the position is \$65,800 per annum.

William F. Leonard

"Fightin' Bill Leonard." Thus read the campaign slogan of a 33-year-old hot shot who has since grown into one of the most respected men in the state.

Referring to the senate race he lost to Ted David in 1960, Leonard recalls the itch that propelled him to "jump in, run, and lose resoundingly." Yet in reflection, he feels it was the best thing that could have happened. He practices law, not politics.

He has absolutely no intention ("heavens no") of running for public office again. He loves law and its practice, a trait he has passed on to each of his three children.

Born in Quincy, Florida, 21 miles Northwest of Tallahassee, on September 4, 1926, William F. Leonard is a self-proclaimed Florida Cracker. In fact, when Judge Hugh Glickstein heard that Warner Brothers was in need of "a red-neck judge type," he knew exactly to whom to refer them. Leonard's ensuing role in the movie "Love Child" is one of many experiences which permits him to say that he has done "just about everything."

The son of a woman who instilled a desire to do something significant with their lives in every one of her ten children, Leonard did his undergraduate work at FSU and received his law degree from the University of Florida. Upon entering U of F in 1943 with the intention of becoming an engineer, he was shortly forced to put his education on hold. It was 32 months in the South Pacific that afforded him the opportunity to grow up and decide that he wanted to study law. After the war, he returned to U of F (served as president of the law fraternity), received his degree, and with diploma in hand headed off to join another war.

In 1953, with a wife, a baby, no money and no job, Leonard began his search for employment from his overseas post.

"I sent out letters to 56 Florida firms and received a response from just about every one," he said. Although most of the letters held regrets, Leonard responds in kind to such letters to this day.

Married to the former Elizabeth Roberts of Fort Lauderdale, Leonard's decision to accept a position with the firm of former Chief Justice Steve O'Connell was based on the fact that his wife's family was here. He had considered offers in Pensacola and Orlando. In 1955, with O'Connell's appointment to the Supreme Court, the firm was named Coleman, Leonard and Morrison.

Leonard's many contributions to the state are too numerous to list. He has served on the Board of Regents since 1982, and has been a member of the Nova University Law Center's Board of Governors since its inception, an organization of which he has been proud to be a part. Having served on the board of directors for Holy Cross for nine years (the last three as chairman), Leonard has one rule of thumb which he attributes to this position. He declines, emphatically, any case against a doctor. A member of the Florida and Broward County Councils of 100 and a director of Southeast Bank (member ten years, chairman four years), Leonard has never found an area of community service he could deny. He has served as president of the Broward County Bar (1974-75) and on the Board of Governors of The Florida Bar from 1976 to 1980.

In his 30-year observance of the 17th Judicial Circuit, Leonard has found that "we've been blessed with having, by and large, good judges in Broward County. We're fortunate to have that," he said.

In fact, if he has any advice to the younger members of the bar, it is to "never blame a loss on a judge, because judges don't lose cases." In addition, one more piece of counsel: never overcharge clients. This comes, ironically, from a man who refers jokingly to his motto: "If you've got five, you've got a lawyer."

Fiscal responsibility is a major concern to Leonard, as is education. He also believes Broward County needs to revitalize its tourist industry and would like to see more business growth downtown.

He and Elizabeth have three children: Bill and Glenn, who have become vital additions to the firm, and Betsy, who is in the process of completing her degree at the University of Florida's Law School. A place has been reserved for her if she decides to follow the family tradition. Five grandchildren are a prime source of the Leonards' enjoyment, as are their friends, football (Gator fans, what else) and travel. The Leonards recently returned from a trip to Mexico City where they celebrated their 35th wedding anniversary.

Looking ahead, Bill Leonard expects to remain hard at work and dedicated to his practice, and to (and no it doesn't sound trite) do what he can for his community, if a man with his commitments can find the time.

Forget about his running for office, however. Having had a hand in the campaigns of Doyle Carlton, George Smathers, Dan Mica and Leroy Collins over the years, fightin' Bill has become "more of a lover these days."

He has been President of the Michigan State Bar Foundation, a trustee of the Federal Bar Foundation of Michigan, a long-time member of the Board of Governors of the American Bar Association, and National Chairperson of the Committee of the Continuing Legal Education Committee of the American Bar Association.

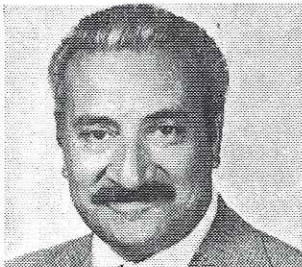
