President's Message

My remarks are going to focus, mainly, on two phrases that are close to every attorney's heart (and pocket-book)—pro bono and mandatory CLE.

The May 19, 1986, issue of the *Fort Lauderdale News* contained an editorial entitled "Bar's image boosted by free help." This article dealt with the Tobias Simon Pro Bono Service Award and The Florida Bar President's Pro Bono Award. Both of these awards were presented by the Supreme Court in Tallahassee at a ceremony held on May 15. Harry Hipler, who practices in Dania, was the recipient of the President's Award for the 17th Judicial Circuit. Harry earned this distinction by contributing more than 250 hours as a participant in Broward Lawyers Care.

Broward Lawyers Care, an organization comprised of Broward County attorneys, works in conjunction with Legal Aid. There are presently more than 200 attorneys participating in this program. These attorneys offer their services, on a pro bono basis, to the less fortunate who must fall within certain economic guidelines as established by Legal Aid. The services performed by the Broward Lawyers Care members are generally in the areas of family law, landlord tenant and consumer law. With the large number of attorneys participating in the program rarely is one called upon to handle more than one or two cases a year and, in many instances, will have no assignments for a year. I urge all of you who are not members to contact President Linda Raspolich Pratt, Esquire, to add your name to the ever growing list of attorneys participating. She will be happy to explain the program to you and to answer any questions you may have as to case assignments, costs, etc. While I dislike the term "pro bono," I feel strongly that we should all lend a hand in the good work being performed by the members of Broward Lawyers Care.

Mandatory continuing legal education, as approved by the Board of Governors of The Florida Bar (by an overwhelming,

enlightened majority of one!), is now before the Supreme Court for approval and implementation. Rest assured that it is coming. I feel that the Broward Bar should immediately begin to plan a program of CLE seminars which will receive appropriate CLE credit. Presented locally, we can have short seminars, cover more useful topics and conduct programs in areas which will not require a half day or a day of travel time.

The local CLE Committee, co-chaired by A.J. Thomas, Jr., and Christine Lee, will be in touch with many of you for suggestions as to subjects to be covered, preferable time of day for seminars, etc. Please give some thought to this matter now so that you can make your preferences known and otherwise help with planning of seminars that will be beneficial to all of us.

You may have noticed in the most recent edition of *The Florida Bar News* an article dealing with the plight of The Florida Bar in placing funds in banks and savings and loans throughout the state. The article pointed out that it was the policy of The Bar to be financially liquid and to maintain only insured accounts. With the never ending mergers of small banks into larger ones and the consolidation of member banks into large statewide organizations, it is becoming more difficult to establish individually insured accounts.

If any of you represent financial institutions or have dealings with a specific bank or savings and loan, it is suggested that you contact me relative to the establishment of a Florida Bar account. Not only will you be aiding and assisting The Florida Bar, but the PR you generate with the local bank will be beneficial to you. Simply drop me a line with the name and telephone number of the person in your bank who can quote rates and otherwise deal with "jumbo" accounts. This information will be forwarded to Tallahassee and that person will be contacted directly by The Bar.

The Board of Governors will be meeting at the Marriott Harbor Beach Resort from July 17th through the 19th. I urge

you to come out and see your Bar in action. It will give you the opportunity to discuss pending matters with your representatives on the Board so that they may better serve you.

Warning

The Supreme Court has adopted rules amending the Rules of Civil Procedure 1.100(c) as follows:

Rule 1.000. Pleadings and Motions

(c) Caption.

(1) Every pleading, motion, order, judgment or other papers shall have a caption containing the name of the court, the file number, the name of the first party on each side with an appropriate indication of other parties and a designation identifying the party filing it and its nature or the nature of the order, as the case may be. *All papers filed in the action shall be styled in such a manner as to indicate clearly the subject matter of the paper and the party requesting or obtaining relief.*

(2) *A civil cover sheet (Form 1.997) shall be completed and filed with the clerk at the time an initial complaint or petition is filed by the party initiating the action. If the cover sheet is not filed, the clerk shall accept the complaint or petition for filing; but all proceedings in the action shall be abated until a properly executed cover sheet is completed and filed. The clerk shall complete the civil cover sheet for a party appearing pro se.*

(3) *A final disposition form (Form 1.998) shall be filed with the clerk by the prevailing party at the time of the filing of the order or judgment which disposes of the action. The clerk shall complete the final disposition for a party appearing pro se, or when the action is dismissed for lack of prosecution pursuant to Rule 1.420(e).*

This amendment shall become effective July 1, 1986. The forms may be obtained from The Florida Bar, Tallahassee, Florida 32301 (904/222-5286).

Attention All Probate Practitioners

Pursuant to a recently issued mandate of the Florida Supreme Court, all Circuit Court Judges, including those in the Probate Division, must issue a report to the Supreme Court every three months regarding the status of all cases. In connection with this mandate the Probate Division of the 17th Judicial Circuit has initiated a review of all estates which have not been closed. All files which are over a year old (and in some cases these which are not a year old) will be reviewed and the Court will issue a Motion to Close for Failure to Prosecute. The motion will be mailed to the personal representative(s) and the attorney for the personal representative(s) and will be generally as follows:

17TH JUDICIAL CIRCUIT,
IN AND FOR BROWARD COUNTY,
FLORIDA, PROBATE DIVISION
IN RE: ESTATE OF CASE NO.
Deceased

SUA SPONTE MOTION TO CLOSE
FOR FAILURE TO PROSECUTE:
NOTICE OF HEARING AND FINAL
ORDER CLOSING ESTATE

THIS CAUSE came on for review by the Court and the Court having determined that the parties hereto have failed to diligently prosecute this action, the Court, sua sponte, ORDERS AND ADJUDGES as follows:

1. Good cause shall be shown why the file should not be closed for failure to prosecute at least five (5) days before the hearing set in Paragraph 3.
2. The showing of good cause shall be in writing and filed in the action. Any facts therein shall be sworn to by a competent person with personal knowledge. It shall include a definite plan and time to close the Estate.
3. If a showing of good cause is filed as provided in Paragraph 2, a hearing on

the question shall be held on the _____ day of _____, 19_____, at _____ AM/PM before Judge _____ or successor, at the Broward County Courthouse, Room _____, Fort Lauderdale, Florida.

4. If the Court finds that good cause has been shown as to why this cause should remain pending and that a plan has been presented to close, then this Court shall enter its Order Denying the Sua Sponte Motion to Close for Failure to Prosecute.

5. If no showing of good cause is found or if no such paper is filed within the time specified in Paragraph 1, this action shall stand closed for failure to prosecute without further Order and the date specified in Paragraph 3 is the effective date for all purposes.

The mailing of this Motion, Notice and Order to each of the addressees listed below shall constitute service of notice of said hearing, and the certificate of the judicial Assistant of the undersigned of such mailing shall be taken as prima facie proof thereof.

Where a pleading alleging good cause is timely filed the attorney for the estate will, of course, be required to attend the hearing. If the case is closed for failure to prosecute, neither the personal representative nor the attorney will be discharged of their responsibilities with regard to the estate.

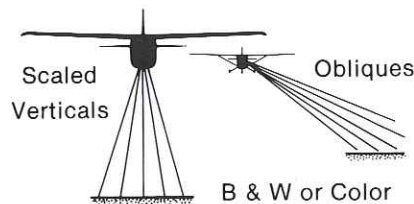

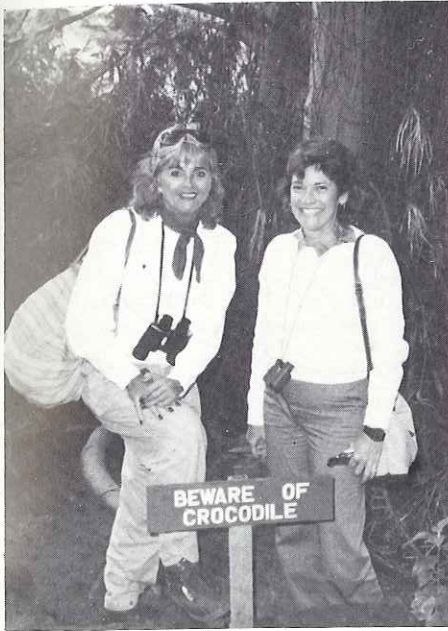

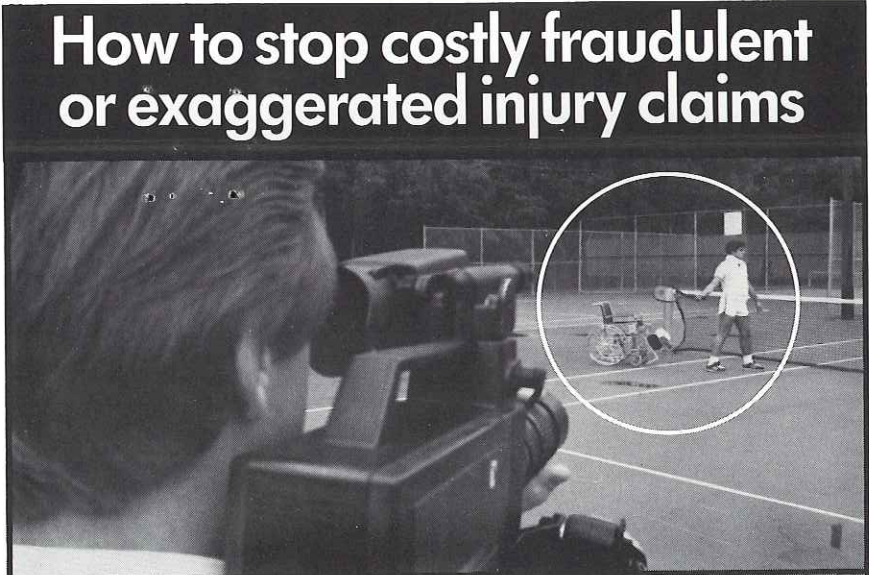
